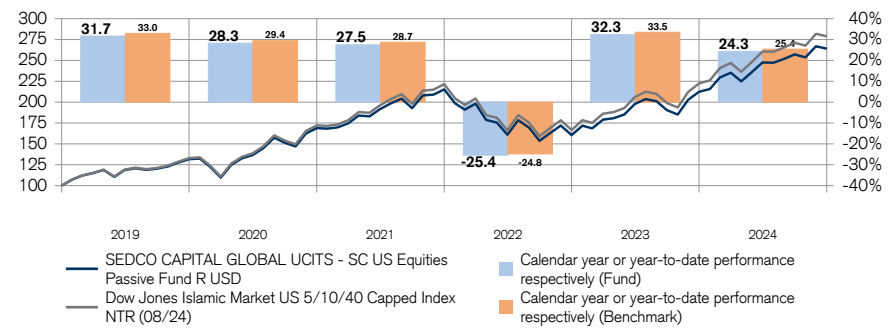

### Investment policy

The Fund aims to invest directly, in accordance with the Shariah Investment Guidelines and the Investment Restrictions, in all or substantially all of the underlying equity securities of the Dow Jones Islamic Market US 5/10/40 Capped Index TR (Bloomberg ticker code: DJIUSUUT) (the "Benchmark"). In doing so, the Fund will endeavor to replicate the weightings in the Benchmark and will comply with the Shariah Investment Guidelines.

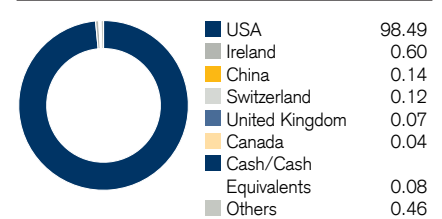

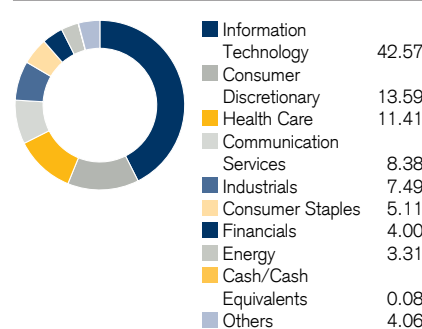
